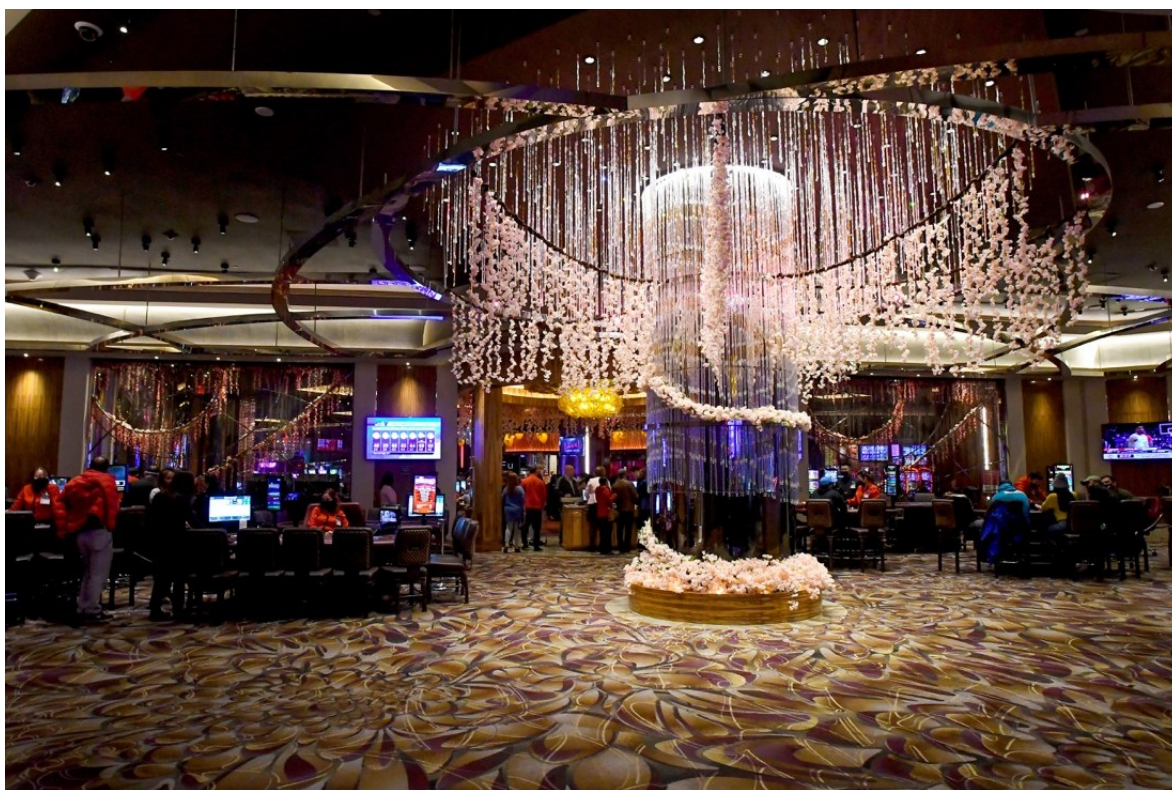

报税季指南:最大程度地减少网络足迹,保护个人在线信息

华府—美国国税局今天敦促民众妥善保护电脑、平板电脑和手机的安全,坚决抵制时下各种诈骗和圈套。纳税人具备可靠的网络安全保护和诈骗识别能力,对于减少税务系统内外的身份盗窃威胁,至关重要。

美国国税局与安全峰会密切合作,该峰会是与州税务机构和私立税务领域的合作伙伴,以帮助保护纳税人信息并防止身份盗用。纳税人和税务专业人士可以采取协助措施,例如最大限度地减少网络安全足迹以及识别常见的骗局与圈套。

以下是最大程度帮助减少欺诈和身份盗用风险的10条提示:

保护个人数据。例如,仅在必要时提供社会安全号码。仅在已被验证为信誉良好的加密网站上提供个人信息或进行金融交易。

保护个人信息。像对待现金一样对待个人信息—不要把它交给任何人。社会安全号码、信用卡号码、银行甚至是水电费账户号码都可以被用来窃取某人的金钱或开设新账户。

使用加强密码。使用您容易记住的密码词组或一系列单词。使用至少10个字

符;12个字符是大多数家庭用户的理想选择。混合字母、数字和特殊字符。尽量使用别人猜不到的组合,不要使用姓名、生日或常见词。不要为多个帐户使用相同的密码,不要将密码告知他人。将密码保存在安全的地方或使用密码管理工具。

为无线网络设置密码和加密保护。如果家庭或企业的Wi-Fi不安全,就会允许范围内的任何电脑访问无线网络,并可能从连接的设备中窃取信息。如果是受密码保护的帐户的情况下,用户也应选择多重因素身份验证过程。多重身份验证对于保护您的密码至关重要。

避免网络钓鱼诈骗。犯罪分子窃取敏感数据的最简单方法就是直接向受害者索取。国税局敦促民众学会识别冒充银行、信用卡公司甚至是国税局等常见机构的网络钓鱼电子邮件(英文)、电话或短信。保证敏感数据的安全,并且:

- o请注意,要求您下载附件或单击某个URL的未经请求的电子邮件可能看似来自您认识的人,例如朋友、同事或税务专业人士,如果他们的电子邮件被骗子盗用或泄露就会出现类似情况。

- o不要假定网络广告、弹出式广告或电

子邮件都来自信誉良好的公司。如果广告或优惠看起来好得令人难以置信,请花点时间查看其背后的公司。

- o切勿从弹出广告中下载“安全”软件。有种常见的骗局是电脑弹出一个广告,说在电脑上检测到病毒。该下载很可能会安装某种类型的恶意软件。信誉良好的安全软件公司不会以这种方式做广告。

使用安全软件。防病毒程序应提供针对病毒、木马、间谍软件和广告软件的防护。国税局敦促每个人使用防病毒程序并对其进行更新。将安全软件设置为自动更新,以便在出现威胁时进行更新。

教育缺乏网络安全经验的民众。儿童和网络经验较少的人可能没有完全意识到打开可疑网页、电子邮件或文档的危险。青少年和年轻用户可能会通过留下个人信息的痕迹被骗子跟踪,从而使自己处于危险之中。

备份文件。没有系统是完全安全的。请将重要文件(包括联邦和州纳税申报表)复制到可移动光盘或备份驱动器以及云存储上。将光盘、驱动器和任何纸质副本存放在安全、上锁的地方。

了解公共Wi-Fi的风险。连接公共

Wi-Fi很方便,而且通常是免费的,但可能并不安全。黑客和网络犯罪分子可以轻松地从这些网络中窃取个人信息。连接到公共Wi-Fi时,请始终使用虚拟专用网络。

查看身份盗窃中心。旨在让大家更便捷地在线获得有关身份盗窃的相关信息,服务于纳税人、税务专业人士和企业。

国税局不会通过电子邮件、短信或社交媒体渠道来与纳税人取得联系并索要个人或财务信息。通常情况下,国税局首先会将纸质账单邮寄给欠税的人。在某些特殊情况下,国税局才会打电话或上门访问住宅或企业。

人们应该警惕冒充国税局窃取个人信息的骗子。有一些方法可以用来甄别(英文)是否真的是国税局打电话或登门造访。

纳税人可以在国税局官网IRS.gov上在线查找常见问题的解答、表格与说明以及易于使用的在线工具。纳税人可以在家中、工作中或随时随地的来使用这些资源来获得所需要的帮助。
