

开始从年金账户拿钱,其税务规定取决 于转入年金的钱是 qualified 计划 , 还是 non-qualified 计划。按IRS的规定,凡是 qualified 计划都有强制最低提取 (Required Minimum Distribution, 简称 RMD)的规定。所谓 qualified 计划,简单 的说就是可以抵税的计划,包括 401K、 403B、TSP、传统 IRA、SEP IRA等等, 投 入这些计划的钱当年可以抵税。若是 qualified 计划,则连本带利都要交税,交多 少税则取决于您当年从年金中拿多少钱,再 加上您其它的收入,包括社安金的收入,来 决定您的税率。

如果放在年金中的钱是税后的钱 (Non-qualified money),则取出来时其增 值部分要交税,本金不需要再交税。但年金 取钱时先拿出来的算gain (如果有gain), 先交税,最后拿出来的算本,不用交税,因为 您事先已交过税了。IRS在计算年金的本 与利采用的是会计学上的LIFO (Last In, First Out)原则,即后产生的利息先拿出来, 最后取出来的算本金。
